## TWO SKELETONS AND A SURVIVING 2-YEAR-OLD

# How a suicide note led police to a shallow grave in a Vadnagar home

POLICE IN Mehsana, Gujarat, have discovered skeletal remains of an adult and a child in a shallow, 3-foot grave under a house in Shahpur village in Vadnagar. They believe the remains are those of a woman who was once the mistress of that house, and her 2-year-old daughter.

The woman, who is thought to have been 29-year-old Priyanka, and the child her daughter Pari, are presumed to have been dead for more than seven months. They were allegedly killed by the woman's husband and the child's father, Girish Babu Parmar.

The remains were found on Monday (May 4) morning, a day after Parmar himself died, allegedly by suicide. The only survivor from the family is now the couple's other child, the twin of

their daughter Pari, who has been living with a relative.

The skeletal remains were discovered hours after the Vadnagar Police completed the panchnama of the body of Parmar, who died after jumping from the fourth floor of GMERS Vadnagar Civil Hospital, about 11 km from his village.

A suicide note was found in Parmar's pocket, in which he confessed to having killed his wife and their child, and said that he was now ending his own life as well, police said.

Police Inspector MNDave of Vadnagar Police told The Indian Express, "Girish Parmar died by suicide at Vadnagar Civil Hospital on May 3, where he had gone expressly for this purpose (to kill himself). During the inquest, we found a suicide note in his pocket where he had written that he had killed his wife and child because both he and his wife were suffering from mental

health issues. He apologised for his actions."

Based on a complaint by Priyanka's grandfather Raman Amtha Yogi (75), the dead man was booked for murder on May 4. Yogi had been looking frantically for Priyanka and her daughter since their disappearance on September 18, 2025. On April 18, tired of the evasive answers that Parmar allegedly gave him, Yogi had filed a 'missing person's' report at

Vadnagar police station.

"After Priyanka and Pari went missing, Priyanka's grandfather Raman Yogi who had cared for her since childhood, tried looking for her, but when ever he asked Girish about their whereabouts, he used to get evasive answers. Girish also refused to approach the police. Finally, Yogi filed a missing person's report in April," PI Dave said.

Police opened an investigation, but they got their breakthrough only after Parmar allegedly killed himself, leaving behind a dying declaration that allegedly pointed them to the grave.

Parmar went to the civil hospital hours before he was to appear before the Vadnagar Police to give a statement on the disappearance of his wife and child.

The next day (May 4), police went to Parmar's house in Shahpur village and searched for

the grave at the place mentioned in the suicide note.

"There, outside a room, we found in the courtyard only one place where there were no tiles, but only plaster. We called into the executive magistrate and began digging there. We found the two severely decomposed bodies at a depth of 3 feet," Dave said.

Police said Parmar worked as a diamond polisher at a unit in Vadnagar, and had married Priyanka four years ago. Two years ago, she had given birth to twins, one of whom lived with them and the other with a relative.

On Parmar's death, Inspector Dave said, "The Head Constable investigating the missing person's report had been questioning all the family members and had called Girish Parmar to give a statement. We believe he died by suicide fearing that his deeds would come to light."

# Akasa Air booked after 'Rs 2.5 cr gold parcel missing in transit'

THE AIRPORT police in Gujarat's Ahmedabad registered a First Information Report (FIR) against Akasa Air with regard to a missing consignment worth Rs 2.5 crore that never reached Bengaluru.

The FIR was registered based on a complaint by Balveersingh Richpalsingh Rathod, security manager at Sequel Logistics.

"We have checked the CCTV footage here at Ahmedabad airport and found that the parcel was loaded onto the aircraft, but the recipients did not get it

in Bengaluru. It could be someone took it there. We are taking statements of officials involved in the transport and handling of the parcel and have sent a team to Bengaluru to investigate as well," A D Chavda, Inspector, Airport Police, said.

According to the complaint, the firm received seven parcels from a jeweller, intended for Titan Ltd, on April 17. One parcel, weighing 13 kg and containing 2.107 kg of gold worth Rs 2.58 crore, went missing. The consignment was handed over to the airline at 2.15 am on April 18 at Sardar Vallabhbhai Patel International Airport, with receipt issued at the time.

The Akasa Air flight reached Bengaluru, where the receiving team from a courier service was handed only six of the seven parcels. Akasa Air was booked under sections 316(2) and 316(4) of the BNS.

A statement attributed to Akasa Air spokesperson received by the Indian Express on May 5, said, "A discrepancy in a valuable cargo consignment carried on Akasa Air cargo service from Ahmedabad to Bengaluru was identified on April 18, 2026. The matter was immediately reported by us to police authorities, and we are cooperating fully with their investigation."

# 'Rituals, blackmail': police arrest 'love guru' who targeted women online

THE CYBERCRIME Branch of the Ahmedabad police said Monday it has arrested a man from Rajasthan and booked two others, who posed as "love gurus" and relationship advisors on Instagram, for extortion, sexual harassment, voyeurism, cheating and criminal intimidation, after a woman alleged she was blackmailed into paying Rs 1.44 lakh.

While the police arrested Rajnish Govindlal Bhargava, a resident of Rajasthan's Bikaner, following the woman's complaint, Vikas Pokhraj Bhargava and Ravi Satyanarayan Bhargava are absconding.

"Bhargava projected himself as an astrologer 'Pooja Kinara GunaMa' on Instagram and used this identity to defraud and blackmail victims under the pretext of performing rituals to make people fall in love/get married/settle divorce issues/ solve relationship problems," said a Cybercrime Police officer.

The police said the accused

created several Instagram IDs and identified himself as a transgender person on social media accounts to hide his male identity.

"The accused contacted victims by offering 'solutions' to personal issues such as relationships or marital problems through 'rituals'. They targeted the victims through online advertisements - mostly females. They contacted around 300 women daily and had 60-65 clients per day for various ceremonies - charge was from Rs 3,000 to Rs 15,000," the police said in a statement.

On the modus operandi following successful contact with

potential victims, Lavina Sinha, Deputy Commissioner of Police (Cyber Crime), said, "The accused collected personal information of the victims, by maintaining continuous contact using multiple mobile numbers, obtained photos from them under the pretext of performing rituals. The accused then edited these photos and threatened to make them viral and forced the victims to undress during video calls citing "shudhikaran vidhi" (cleansing rituals) and recorded the screen...."

The police said the gang earned between Rs 40 lakh and Rs 50 lakh over the past two-and-a-half years.
